Yangon Region Government Not Different from the Previous Term, Daw Sandar Min Criticizes

7th September 2016

Yangon Region Government is diminishing the role of the regional parliament, and is not much different from the previous government, criticized Daw Sandar Min, who heads the Planning and Economic Committee. The regional government was criticized for not reporting public projects to respective parliamentary committees.

"The parliament shall check and balance with the government. According to the Article 251 of the Constitution, the regional government shall implement projects with the approval of the regional hluttaw. It is important to report to all the corresponding MPs in case of mega projects in Yangon Region and to the Hluttaw in case of public projects and obtain approval from the Hluttaw. Till now we have not received comprehensive explanation of Yangon Urban Development Plan, the most important project in Yangon. We do not have a clue: when the urban planning will start off, how it is designed and what the features are. Does the plan involve any land confiscation? Of couse, we want to know whether the plan will start off with the release of confiscation permit," said Daw Sandar Min.

Neither has the current government reported on Yangon Urban Development Plan by the previous government nor the Yangon Public Transportion System and Yangon circular railway which are to be implemented under this government, she added. Those actions lack transparency in a similar manner with the previous government and are against the Constitution.

"There are even projects that we learned only after they are mentioned in news journals. We do not know anything when people ask," she went on saying.



She later said that she would report this gap_between the regional government and the Hluttaw_ to the Speaker of Yangon Region Hluttaw and continue to take actions.

Shan State New Parliament Building to be Built to the West of the Current Hluttaw Office



6th September 2016

On 5th September, Shan State Government announced the proposed site for the new parliamentary building and the site is stated to be to the west of the current Hluttaw Office.

The newly chosen site is on the Eain Taw Yar Street, Thittaw Ward, Taunggyi and is to the west of the current hluttaw office. The site has only 4 old trees, 2 dry trees and 1 small tree so probably the site with the minimum impacts, said the Planning and Economic Minister U Soe Nyunt Lwin.

On 5th September, Shan State Government had a press conference at the Government Meeting Hall to where Taunggyi-based CSOs, the groups that opposed the previously proposed site and the media were invited.

The new site, which will have the least impact, has been chosen since the locals rejected the previously proposed site which is home to a lot of aged pine trees, said the Chief Minister Dr. Linn Htut.

The newly proposed site by the Shan State Government has very few aged trees that the locals approve without any objections, said Daw Cherry Kyaw, a chairperson of Living Earth Green Network.

Ayeyarwady Offshore Transport Plan Submitted at the Regional Parliament

During the second regular session of the 2nd Ayeyar-wady Region Hluttaw, the Ayeyarwady Offshore Transport Plan, worth \$400 Million, was proposed. SIM Company first submitted the proposal to Myanmar Investment Commission (MIC) and later to the regional government and the Hluttaw in compliance with MIC rules, said U Hla Kyaw, who is the regional Minister of Planning and Finance.

"The proposal is merely a summary and does not

elaborate. It only describes benefits, not negative impacts. Any projects have both postive and negative impacts. Public opinion is crucial. We have to disclose the proposal to the public and listen to the opinions," said U Phyo Zaw Shwe, a representative from Ngapuda Constituency 1.

The Speaker, U Aung Kyaw Khine, has instructed the Economic and Industrial Development Committee of the regional hluttaw to review the SIM Company's proposal, submitted by the Planning and Finance Minister, and to submit the review findings to the hluttaw on 28th September.
