State-level Committee Removed in Mon State Municipal Law Drafting

Mon State Hluttaw has proposed to remove the state-level committee in a draft amendment to the Mon State Municipal Law since people consider that Mon State Municipal Committee's has weakness in being money-driven, lack of accountability and transparency, claimedDr.AungNaingOo, the Deputy Speaker of Mon State Hluttaw.

He went on giving examples on-Mawlamyine Strand Road improvement and ThitPonSait Housing projects. None of these projectsmet people's will, and were seen as only beneficial for the government. The current state level municipal committee can carry out work for Mawlamyinecapital and not in other towns. The draft amendment will be submitted to the Mon State Hluttaw fourth regular session in December.

The decision to abolish the state-level committee which public considered unnecessary was proper, and by doing so the township level committee would be able to implement regional development activaties more effectively, said U Nay Win, Mon State Municipal Committee member.

Dr.AungNaingOo added that the draft

amendment was planned upon public's opinion to remove state level committee and to keep township level only.

"Now we can see that the state-level municipal committee is cancelled, which public can get involved in and cooperate in terms of democracy," commented U Maung Maung Zaw Htun, a resident of Mawlamyine.

Mon State Municipal Law or Mon State Development Law was first passed in 2012 by the previous State Hluttaw, but the law was then amended in 2013 and 2015 respectively.

Investigation Team to Handle Fresh Water Fisheries Law Offenders

27th November 2016

An investigation team has been formed in Ayeyarwady to inspect Ayeyarwady Fresh Water Fisheries Law (2012/No.2) offenders and officials who do not penalize offenders, said U Ba Hein, the Minister of Agriculture, Livestock, Natural Resources and Environment.

The minister said so in response to Daw Khin Moe Wah (Thabaung 1) urging the cabinet to handle the fisheries issues effectively during the third regular session of the second Ayeyarwady Region Hluttaw.

Offences such as electric fishing, chemical usage after water removal from lakes, setting up fishingnets and stockpiling fish without license, permitting to catch fish before auctions are not being penalized by government officials, DawKhin Moe Wah stated.

It was decided through a cabinet meeting to form an investigation team to handle law offences. The team would be led by a township administrator while it would also include officials from Fishery Departments, township police director, experts, 5 people from CSO and an MP, according to the cabinet office.

Two Commissions Formed at Tanintharyi Region Hluttaw

At the third regular session of the Second Tanintharyi Region Hluttaw which started on 28th November, budget review and advisory commission and legislation commission were formed.

"We have been trying to form these commissions," the Speaker U Khin Maung Aye said.

He added that the main difficulty was in reviewing external experts and encouraging them to get involved.

There are 9 members including advocates, high grade pleaders, a Professor from Law Department, Dawei University and legal officials while U Hla Htwe, a representative of Yebyu Constituency, will be the chairperson of the newly formed legislation commission.

"We will review 11 laws approved by the previous parliament," said U Hla Htwe.

Budget review and advisory commission led by U Kyaw Min (aka U Phoe Min) has 12 members in total, including an MP and government officials. (*Ref: Extracted from Tanintharyi Journal*)
